

This is regarding Compliance Report submitted by Nandha College of Pharmacy, Koorapalayam Pirivu, Pichandampalayam Post, Erode-638 052, Tamil Nadu for the UG-Pharmacy program which was accredited by NBA for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30.06.2021. The program was granted accreditation for the Academic Year 2021-22 i.e. upto 30/06/2022 on account of present pandemic situation due to Corona Virus.

2. An Expert Team conducted data verification of the program on 11th June, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. - 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. The program has been granted accreditation for further 3 years. Nandha College of Pharmacy, Koorapalayam Pirivu, Pichandampalayam Post, Erode-638 052, Tamil Nadu should submit fresh online application under First Cycle SAR January 2016 document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
- 5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Nandha College of Pharmacy, Koorapalayam Pirivu, Pichandampalayam Post, Erode-638 052, Tamil Nadu as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
- 6. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
