PREAMBLE :-

In the reference 2nd cited, the Chairman, Sri Nandha Educational Trust, 291, Chinnamuthu Street, E.K.Valasu, Erode – 638 011, in their letter dated. 18.05.2021 had forwarded the “Essentiality Certificate” issued by the Government of Tamil Nadu, Health and Family Welfare Department, Chennai vide G.O. Lr.(4D) No.03/MCA-2/2021 dt.19.02.2021 for starting of MBBS Course at **Perundurai Main Road, Pitchadampalayam Post, Erode District** in the name and style as “**Nandha Medical College and Hospital**” with an annual intake of One Hundred and Fifty (150) Seats and also requested to issue “Letter of Consent of Affiliation”.

In pursuance of the orders of the State Government and on the request of the Chairman, Sri Nandha Educational Trust, Erode, this University conducted an Inspection for considering the grant of Letter of Consent of Affiliation on 29.07.2022.

In the reference 3rd cited, this University had issued a Letter of Consent of Affiliation on 05.08.2022 to “**Nandha Medical College and Hospital**”, **Perundurai Main Road, Pitchadampalayam Post, Erode District** for starting of MBBS Degree Course with an annual intake of 150 Seats for the academic year 2023-2024 based on the inspection report so as to apply to the Government of India, New Delhi for obtaining permission. The same was approved in 293rd Governing Council meeting held on 12.10.2022.

In the reference 5th cited, the National Medical Commission, New Delhi has conveyed the Letter of Permission of the Medical Assessment and Rating Board (MARB) for starting of new Medical College at **Nandha Medical College and Hospital**”, **Perundurai Main Road, Pitchadampalayam Post, Erode District**, in the State of Tamilnadu under the Tamil Nadu Dr. MGR Medical University, Chennai with annual intake of 150 MBBS Seats u/s 26(1) (a) (b) and 28(1) (2) of the NMC Act, 2019 for the academic year 2023-2024.

This permission for starting of above mentioned MBBS Course and admission of students will be for such time the first batch of students admitted against the above course appears for the final examination in the subject. The college authorities may take up the matter for recognition of the qualification under section 35(2) of the IMC Act at the time of first batch admitted against the sanctioned intake of 150 MBBS seats appears of final examination with National Medical Commission.

In the reference 7th cited, the Chairman, Sri Nandha Educational Trust, 291, Chinnamuthu Street, E.K.Valasu, Erode – 638 011 has requested to grant Orders of Provisional Affiliation for starting the MBBS Degree Course with an annual intake of 150 MBBS seats for the academic year **2023 -2024**.

On receipt of Letter of Permission, this University has constituted the inspection team to verify the Infrastructural facilities, teaching staff etc., for considering the grant of **Provisional Affiliation Orders** for establishment of a new Medical College in the name “**Nandha Medical College and Hospital**”, **Perundurai Main Road, Pitchadampalayam Post, Erode District** for MBBS Degree Course with an annual intake of One Hundred and Fifty (150) seats for the academic year **2023 -2024**. The inspection team conducted the inspection and submitted their report to this University which has stated that the infrastructure, Faculty, Clinical Material, Equipment etc., and all other facilities are verified physically and found satisfactory.

ORDER:

In pursuance of the permission granted by the National Medical Commission, New Delhi and the report of Inspection Commission, this University hereby grants the orders of **"Provisional Affiliation"** to **"Nandha Medical College and Hospital"**, Perundurai Main Road, Pitchadampalayam Post, Erode District for starting First MBBS Degree Course with an annual intake of One Hundred and Fifty (150) seats for the academic year 2023-2024, subject to the following conditions:

1. **"Nandha Medical College and Hospital"**, Perundurai Main Road, Pitchadampalayam Post, Erode District shall abide by the provisions of the Tamil Nadu, Dr. M.G.R. Medical University Act, 1987 (Tamil Nadu Act 37 of 1987) and by Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Medical Colleges framed from time to time.
2. The institution shall agree for the inspection of the college by the Tamil Nadu Dr. M.G.R. Medical University at any time according to the Statutes, Ordinance, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Medical Colleges framed from time to time.
3. The institution shall abide by the Statutes, Ordinance, Regulations and Rules framed by the Tamil Nadu Dr. M.G.R. Medical University on matters of Syllabus, Examinations, Code of conduct, Curricular Activities etc., framed from time to time.
4. The conditions that may be prescribed by the National Medical Commission, New Delhi shall be fulfilled. The standard and requirement prescribed by National Medical Commission, New Delhi from time to time for admission to Medical Colleges shall be followed strictly.
5. The sanctioned strength for the MBBS Degree Course is **150 (One Hundred and Fifty only)** for the academic year **2023 - 2024**. The maximum number of students that may be admitted to the course shall not exceed the sanctioned strength.
6. The admission procedure as enunciated by the Supreme Court of India, shall be followed.
7. The admission procedure as laid down in Government order should be followed. While making admission, the rule of reservation of the Government of Tamil Nadu shall be adopted strictly. Any admission made over and above will not be permissible on any account.
8. Only eligible candidates according to the regulations of this University shall be admitted.
9. No candidate should be admitted before the date of issue of this Provisional Affiliation Order, as informed in this University's letter dated 05.08.2022 for issue of Letter of Consent of Affiliation.
10. The candidates should be admitted in the capacity of **150** seats before the prescribed cutoff date for MBBS Degree Course and they will be registered to take up their 1st year examination as per existing regulations.
11. The course should be conducted in accordance with the regulation and syllabus approved by this University and National Medical Commission, New Delhi.

12. The staff, student ratio prescribed by the National Medical Commission, New Delhi shall be followed. The staff pattern with prescribed qualification by the University as well as the National Medical Commission, New Delhi should be followed.
13. The Institution shall furnish all the teaching and other staff details with qualification, experience, date of joining etc., whenever required by the University.
14. Required furniture shall be provided wherever they are necessary.
15. Hostel accommodation shall be made available for the students.
16. The Institution shall furnish a budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the entire course of study. The management of the medical college shall show evidence of an annual income of not less than INR. 15,00,00,000/- (INR. Fifteen crores only) for the maintenance of the college and hospital.
17. The Security Deposit of INR. 1,00,00,000/- (INR. One Crore) i.e., Ist Instalment INR. 20,00,000/-, IInd Instalment INR. 40,00,000/- & IIIrd Instalment INR. 40,00,000/- created in the joint name of "The Registrar, The Tamil Nadu Dr. M.G.R. Medical University, Chennai & the Trust name of the institution in a Nationalised Bank / Government undertaking / Corporation. The Second and Third installment should be created and submitted to this University during 2nd and 3rd year.
18. The College shall furnish a "Utilization Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Medical College.
19. There shall not be any financial commitment either to this University or to the Government.
20. The Institution shall obtain the renewal permission of the Government of India for an intake of 150 seats every year and submit the copy of the same to the University.
21. The Institution shall obtain the recognition of the National Medical Commission, New Delhi for 150 seats and submit the copy of the same to this University.
22. Furnishing of false information to the University any matter or suppression of facts while furnishing information to the University or violation of any of the Statues, Ordinances, Regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.
23. Facilities should be made available for conducting University Examinations. During the University Examinations, the question paper will be sent through internet for which the following equipments have to be purchased and kept ready by the Institution.

24. After fulfilling all the conditions required to be fulfilled by the college under the Tamil Nadu Dr. M.G.R. Medical University (Affiliation of Medical Colleges) Statutes, by the end of Ist year MBBS Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the second year MBBS Degree Course of study along with renewal permission obtained from the National Medical Commission, New Delhi.

25. It is mandatory to develop a biometric attendance, website on the Medical College / Institution and display all the information of the college, courses offered, faculty available and their experience of the last 5 years, students joined, and affiliating University. To display the hospital services, facilities available and the equipment in each speciality and also showing OP and IP census including births and deaths as per the Municipal / Govt. records.


26. The Management shall follow transparent and reasonable method of admission for the Management Quota as stipulated in the Government Order in force.
